I understand that I will receive payment of \$200.00 per acre up to a maximum of 2 acres after establishment; and the pollinator seeds are provided to me at no cost for the 2-acres site as a one-time provision. Site verification will be in-person by PEIDA. For payment to occur, PEIS CIA must receive establishment verification by September 25, 2024.
